## Editorial

This regular issue of *New Zealand Sociology* is sandwiched between the special issue derived from the 2007 joint Australia/New Zealand conference and the forthcoming special issue on ‘Maori Sociology’ to be guest-edited by Robert Webb, Evan Poata-Smith and Juan Tauri. As well as the usual articles – including the prize winner of the 2008 student essay competition - this issue includes several book reviews (one a more extended review essay and one an extended review) and two obituaries. During the 2008 SAANZ conference in Dunedin a review symposium on Chris Brickell’s book was organised and this issue includes a slightly-edited version of a tape recording of this. Some web-attachments can also be called up from this review symposium and other material in this issue. We draw attention to Paul Spoonley’s intellectual biography of Ranganui Walker by including (with permission) a picture of its front cover: see below. A new feature in this issue are two invited ‘research notes’ providing descriptions of large-scale funded projects ongoing in New Zealand. It seems quite a reasonable observation that there is too wide a gap between the funded projects comprising one sector of the research front of New Zealand sociology and the teaching and smaller-scale research being carried out by other sociologists and these commissioned notes attempt to fill this gap: hopefully more will be published in the future. Finally, it is not our intention to fill too much space in *New Zealand Sociology* with conference reports, but the two that are included – by coincidence held at exactly the same time – have useful lessons about how conferences with differing formats can assist with the knowledge production process.
